When is the Next ISO 9001 Update?

The Technical Committee are planning for the next decade of management system standards with the next revision of ISO 9001 due for release in the autumn of 2015. There is currently a move underway to develop a set of unified management system standards that share a common structure which closely aligns with the identical, core requirements of each system.

ISO 9001:2015 adopts the clause structure specified in Annex SL, which is now the required framework for all new and revised ISO Standards. The stated intention behind this is to ensure that ISO 9001 is aligned with other management systems standards.

The new updated ISO 9001:2015 standard includes fewer clauses (eight instead of ten), a revised high-level structure that forms a new common core for all quality standards (Annex SL), and several terminology

ISO 9001 does not establish a minimum of approvals required, ISO 9001 it does not provide a format for documents nor does it require you to have a document number.
